

TERMS AND CONDITIONS – BINGO BONANZA 2021

1. This event will be held at RSL Club Southport, 36 Scarborough Street Southport, QLD, 4215 on Sunday 3rd October 2021 at 11am.
2. Total amount of prizes on offer is \$22,000. 20 x \$350 games 1 x \$5,000 Jackpot
3. Major TREBLE Jackpot - \$10,000 (i.e. \$1,000 Line; \$2,000 2 Lines; \$7,000)
4. Packages available for sale from Tuesday 31st August 2021 9:30am.
5. Package includes 8 full books of 20 games & 8 sheets of each jackpot.
6. There will be up to 200 PET machines available for purchase.
7. Cost to play is \$200 per person per package (8 sets).
8. The event is limited to a maximum 200 participants.
9. All ages are eligible to participate.
10. Maximum one package per person will be played on PET machine, however paper tickets can be purchased separately at \$20 per book, \$2 per jackpot (\$5,000) and \$3 per treble (\$10,000)
11. In the event of a ticket holder not being present, their package will be forfeited and will not be played by another patron already playing their package.
12. The package is transferable to another person however a maximum of one package per person (on PET) can be played.
13. Purchases can be done through Ticket Search Online or Reception.
14. A non-refundable \$50 deposit is required upon purchase
15. Payment must be made in full by **2pm on Wednesday 29th September 2021.**
16. If payment is not made in full by the closing date, deposit will be forfeited, and package will be available for resale.
17. If required amount of packages (110) are not sold, the event will be cancelled and refunds of total payments will be made including non refundable deposits.
18. All prizes up to \$5,000 will be paid in cash with remaining winnings being paid by cheque.
19. The winners must, at the Promoter's request, participate in all promotional activity (such as publicity and photography) surrounding the winning of any prize, free of charge, and they consent to the Promoter using their names and images in promotional material.
20. The caller's decision is final and no correspondence will be entered into.
21. The Club may, in its sole discretion, disqualify all entries from, and prohibit further participation in this competition by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the competition or acts in violation of these conditions, acts in a disruptive manner or acts with the intent or effect of annoying, abusing, threatening or harassing any other person.
